Mr. Wilson said it was \$200,000 less. Original proposal was to do a metal building, which was cheaper.

Mr. Biesemeyer stated we need to go back to the drawing board and see what we actually need for a building.

Ms. Hough stated she agrees with Bob, could we down size the building and get the price down.
